1. About POLICY ENLARGE

POLICY ENLARGE - R&I Policy Support for Enlargement Countries - is a Horizon Europe project focused on contributing to the alignment of national and regional research, innovation, and education policies for the countries Albania, Bosnia and Herzegovina, Georgia, Kosovo*, Moldova, Montenegro, North Macedonia, Serbia, Türkiye, and Ukraine, hereinafter named enlargement countries¹. The project aims to support the integration of enlargement countries into EU Research and Innovation actions and policy-making through policy dialogue, capacity building, mutual learning and targeted support to cross-border cooperation.

Through its Open Call, POLICY ENLARGE will provide Financial Support to Third Parties for small cross-border projects, collaborative uptake of results and people-to-people cooperation activities involving stakeholders from enlargement countries. These activities are expected to contribute to stronger cooperation, better internationalisation and closer alignment with EU Research and Innovation priorities.

Call deadline:	This is a continuously open call with several Cut-off Dates. • Cut-off Date 1: 12 November 2026, 17:00 Brussels time • Cut-off Date 2: 5 May 2027, 17:00 Brussels time • Cut-off Date 3: 3 November 2027, 17:00 Brussels time • Cut-off Date 4 / final call deadline: 3 May 2028, 17:00 Brussels time Cut-off Dates and call closing dates might be adjusted depending on the Project needs and the value of the available funds.
Max. grant amount	The max. grant amount is up to EUR 8,000 per third-party project (with a strict limit of up to EUR 4,000 per individual consortium partner) under Funding Instrument #1: Small Grants for Joint Regional Innovation Actions and Funding Instrument #2: Small Grants for Collaborative Uptake of Results, and up to EUR 5,000 per mobility grant under Funding Instrument #3: Small Grants for People-to-People Cooperation Projects, based on the budget included in the application form (with a strict limit of up to EUR 4,000 per individual consortium partner). The Project budget is part of the application form. The total amount you list will be fixed and will determine the grant you'll receive. The funding rate is up to 80% of the budget included in your application form. This means you must cover the remaining 20% from your own resources (co-funding), which must be clearly demonstrated in the budget of your application form. The grant will be paid as a lump sum.
How to apply?	Submit your proposal via our online form https://opportunities.getonepass.eu/opportunities/policy-enlarge before the relevant Cut-off Date. Your application must be in English, and all mandatory sections must be completed. Proposals cannot be modified after submission. Multiple submissions for the same Funding Instrument and the same Cut-off Date are not permitted. If the same entity submits more than one proposal for the same Funding Instrument and Cut-off Date, only the most recently submitted proposal will be taken into consideration. Each third party may benefit from no more than one POLICY ENLARGE Funding Instrument/Grant throughout the entire Open Call, irrespective of the Funding Instrument or Cut-off Date. If the same third party is included in more than one proposal selected for funding, only the highest-scoring proposal involving that third party will be considered for funding. The other proposal(s) may be replaced by the next-ranked eligible proposal(s), in accordance with the ranking list. If a third party has already received POLICY ENLARGE funding under a previous Cut-off Date, any subsequent proposal involving the same third party as a funded participant shall be considered ineligible for funding.



Who can apply?	For Funding Instrument #1: Small Grants for Joint Regional Innovation Actions and Funding Instrument #2: Small Grants for Collaborative Uptake of Results: consortia including at least two independent legal entities, each established in a different enlargement country are eligible. The participating entities can be Companies², Research Organisations³ and Academia Research Groups⁴, Non-profit entities⁵, Digital Innovation Hubs⁶ /European Digital Innovation Hubs⁷, and others relevant R&I actors. For Funding Instrument #3: Small Grants for People-to-People Cooperation Projects: consortia including participation of Researchers, Artists, or Entrepreneurs - affiliated with independent legal entities, established either in different Enlargement Countries or in an Enlargement Country and an EU Member State are eligible. Secondees, i.e. applicants for the mobility programme, must be citizens of an eligible enlargement country (please see below) or hold a permanent residence permit in an enlargement country.

Additional conditions related to who can apply?	To be eligible, applicants shall be based in the Enlargement Countries, which are Albania, Bosnia and Herzegovina, Georgia, Kosovo, Moldova, Montenegro, North Macedonia, Serbia, Türkiye, and Ukraine. In the case of Funding Instrument #3: Small Grants for People-to-People Cooperation Projects, the hosting entity can also be from any EU Member State and its Overseas Countries and Territories (OCT) or Horizon Europe Associated Country. POLICY ENLARGE partners and their affiliated entities can NOT be involved in the Financial Support to Third Parties recipients' projects nor their employees and associates, including persons working under employment contract or contract equal or similar to employment contract and board members. Former employees and associates shall also be excluded if they were involved in the project execution at any stage. Applicants under EU restrictive measures are ineligible: - Following the Council Implementing Decision (EU) 2022/2506, as of 16 December 2022, no legal commitments can be signed with Hungarian public interest trusts established under Hungarian Act IX of 2021 or any entity they maintain. Other restrictive measures: - Since June 2024, the European Commission has suspended financial bilateral assistance directly benefiting Georgian authorities until further notice. As the EU continues to fund programmes directly benefiting Georgian citizens and has increased support to civil society and independent media, the project will support Georgian researchers. Regulation (EU) 2021/947, in particular Articles 3, 8, 19, 20, and 25 et seq., in conjunction with Financial Regulation (EU, Euratom) 2024/2509 and the relevant Commission implementing decisions establishing or amending assistance programs for Georgia.
Project scope - type of activities that can be funded	The following types of activities can be funded: • Small grants supporting the development of collaborative R&I projects, access EU funding opportunities, strengthen R&I management and technology transfer capacities, and contribute to evidence-based policy reforms and digital and green transformation. • Small Grants for Collaborative Uptake of Results: small grants aimed at implementing joint activities to support R&I, regulatory, or societal uptake of results. • Small Grants for People-to-People Cooperation Projects: small grants aimed at implementing people-to-people cooperation projects with and within enlargement countries. For a more detailed description and examples of eligible activities, please check Annex I.



Number of grants and total funding available	We will support up to 45 Projects in this Open Call: • up to 15 projects under the Small Grants for Joint Regional Innovation Actions, • up to 10 projects under the Small Grants for Collaborative Uptake of Results, and • up to 20 mobility grants under the Small Grants for People-to-People Cooperation Projects. The total budget available for this Open Call is EUR 300,000. POLICY ENLARGE expects to select an indicative number of proposals under each Cut-off Date (up to 4 under Funding Instrument #1, up to 3 under Funding Instrument #2, and up to 5 under Funding Instrument #3). The project aims to select at least 1 Project per enlargement country. However, the final number of selected proposals, the distribution across countries, and the Cut-off Dates themselves may be flexibly adjusted based on the quantity and quality of applications and available budget. Any unused budget or places will be transferred to subsequent Cut-off Dates.
Duration of the Support Programme	The Grant is offered together with the POLICY ENLARGE Support Programme. Our Programme lasts up to 6 months.
Support Programme	Our Support Programme covers the implementation of the selected Third Party Projects under the three POLICY ENLARGE Funding Instruments. The Support Programme is divided into two main stages over the 6 months. Third-party projects will receive their grant in instalments upon the successful completion of each stage. For more details on the exact payment schedule and how each project's progress will be evaluated, please refer to the Payment Conditions and Milestones Review chapters.
Ground rules and formal requirements	1. Submission deadline: Only proposals submitted through the online form https://opportunities.getonepass.eu/opportunities/policy-enlarge before the relevant Cut-off Date will be considered. 2. Language requirement: Proposals must be written in English. If mandatory sections are in another language, the proposal will be rejected. Non-mandatory sections in another language will not be evaluated, but the proposal will remain valid. 3. Data accuracy: The information you provide must be correct, complete, and allow proper evaluation. Extra material provided by you that was not requested in the form will not be considered. Although we may use other resources to verify that the provided data is true. 4. Completeness: Ensure all required fields are filled. Proposals cannot be modified after submission, unless there's an error in the administrative data (e.g., contact info). For corrections, email us with the proposal ID. 5. European dimension: Your proposal should align with EU goals and contribute to creating a positive impact within the EU, in particular by supporting the integration of enlargement countries into EU Research and Innovation actions and policy making. 6. Conflicts of interest: We will check for any conflicts of interest between applicants and Consortium partners. POLICY ENLARGE

	partners, their affiliated entities, and their employees cannot participate. Each case of conflict will be reviewed individually. Former employees and associates shall also be excluded if they were involved in the project execution at any stage. 7. Financial stability: Entities under liquidation, in financial difficulty, or excluded from receiving EU funding are not eligible. We also exclude companies in bankruptcy. 8. Original work: Execution of your project should not violate third-party IPR. It must be based on your intellectual property or you must be allowed to use third-party rights. IPR to the project can not be subject to any dispute. 9. AI content: The use of AI tools to improve clarity and structure is permitted, provided the content remains accurate and fact-based. Applications may be rejected if found to be AI-generated and lacking a factual foundation. All submissions must be authentic reflections of the project, and the applicant team must evidence the technical and operational capacity required for implementation. Providing unverifiable or non-authentic information is grounds for immediate rejection. 10. Other requirements: each third party may not benefit from more than one POLICY ENLARGE Funding Instrument / Grant. The exception to this rule may be applicable in case of large entities like Universities, Public authorities, if different departments are engaged in the activities. The amount entities receive through the POLICY ENLARGE Funding Instruments cannot be higher than EUR 60,000. 11. Gender Equality Plan (GEP): Public bodies, universities, and research organisations from EU or Associated countries must have a GEP. Acceptance of rules: By applying, you agree to the Open Call Terms and Conditions outlined in this document.

3. Submission and evaluation process

Only proposals submitted through the online form <https://opportunities.getonepass.eu/opportunities/policy-enlarge> before the [relevant Cut-off date](#) will be considered. You will receive an email confirmation once the form has been successfully submitted. If you do not receive a confirmation email, please contact us immediately.



Our evaluation process is transparent, fair and equal to all participants. We will evaluate your project in a few phases described below. We will inform you about the results of the evaluation as soon as they become available.

3.1. Initial Check

After the closure of the open call, the system will review your proposal to ensure it meets the Call Terms and Conditions ([section 1](#)). This check will be based on the declarations in your proposal.

The projects that do not comply with those criteria will be excluded and marked as ineligible. After the evaluation process, all applicants will receive information about the results.

3.2. Pre-scoring

The Selection Committee might decide to apply Pre-scoring in case of a large number of applications on the relevant Cut-off Date and Funding Instrument. Proposals will be automatically scored based on specific criteria related to the selected Funding Instrument:

- Excellence & entity profile (up to 20 points): evaluating the type of entities involved in the consortium, their complementary strengths, and the added value the partners or host organisation bring to the cross-border cooperation.
- Impact (up to 20 points): expected use of the project output or transfer-back of knowledge, and its direct link with Research and Innovation or policy needs in enlargement countries.
- Implementation & talent (up to 20 points): evaluating the talent, specific skills, and proven experience of the core team assigned to execute the project, as well as the gender balance and readiness of the proposed work plan or secondment.

As an applicant, choose the option that best fits your project for each criterion and confirm all your statements are true. We will check them during the next phases. If we identify false information, we may reject the proposal.

Each pre-scoring question (2 questions per criterion) will be scored from 0 to 10 points. Your project can earn up to 60 points. The top applications, up to twice the number of proposals expected to be funded under the relevant Cut-off Date and Funding Instrument, will move on to the next phase.

Ties will be solved using the following criteria, listed in order of priority:

- The highest score obtained in Implementation and Budget;
- The highest score obtained in Impact;
- The highest score obtained in Excellence.

3.3. External Evaluation

Eligible proposals will be evaluated by 2 independent experts using predefined award criteria:



- **EXCELLENCE:** Ambition of the proposed third-party project, including its contribution to closer links between research and innovation and to institutional cooperation producing high-quality knowledge underpinning economic and societal solutions. The evaluators will also assess the level of innovation, the added value and contribution of the project to enlargement countries, and the soundness of the approach and credibility of the proposed methodology. For Funding Instrument #3: Small Grants for People-to-People Cooperation Projects, the extent and quality of the accompanying activities at the host institution, such as training, capacity building and soft skills development, will also be considered.
- **IMPACT:** Market relevance and relevance to the regional, economy-level or local policy context, including, where relevant, the indicative R&I policy priorities and challenges listed in Annex 2. The evaluators will assess how effectively the project enables enlargement countries to better internationalise and integrate into EU Research and Innovation actions and policy making. Environmental and social impact will also be considered, including the contribution to closer integration with EU priorities, notably the Green Deal and digital transformation, with emphasis on research, innovation and knowledge transfer. For Funding Instrument #3: Small Grants for People-to-People Cooperation Projects, the contribution to joint follow-up measures, long-term cooperation, career perspectives and skills development of secondees will also be assessed.
- **IMPLEMENTATION:** Management and leadership qualities of the team, ability to carry through the proposed ideas, cross-border composition, background and skills base, and gender balance. The evaluators will also assess the quality and effectiveness of the resources assigned to achieve the objectives, work plan and deliverables proposed, including the estimated budget. For Funding Instrument #3: Small Grants for People-to-People Cooperation Projects, hosting arrangements and allocation of resources will also be considered.

Each criterion will be scored on a scale from 0 to 5, with evaluators providing individual reports and scores based on these criteria. Once the Individual Evaluation Reports are submitted, the final score for each criterion will be calculated as the average of the individual assessments provided by each evaluator on each criterion. The final score per application will be calculated as the sum of the final scores for each criterion.

For each criterion, the minimum threshold is 3 out of 5 points. **The maximum total score will be 15 points, with a minimum total threshold of 10 points.**

In case of major deviations between the two evaluations of more than 5 points in the total evaluation, a third evaluator will be engaged, and the review that differs the most from the mean of the three reviews will be discarded.

As a result of this phase, an Independent Evaluation Ranking List will be produced for each Funding Instrument.

Ties will be solved using the following criteria, listed in order of priority:



1. The highest score obtained in Section Impact;
2. Other factors related to the objectives of the Open Call and the need to ensure a balanced selection across enlargement countries and Funding Instruments. In the case of Funding Instrument #3, intra-enlargement cooperation will be prioritised where relevant.
3. Gender balance among the personnel responsible for carrying out the activities;

3.4. Consensus Meeting

The Selection Committee will review and discuss the results of the previous evaluation stage. The Selection Committee will aim to reach consensus on the list of proposals to be selected. If consensus cannot be achieved, the decision will be taken by a two-thirds majority vote

The Selection Committee may be supported, if needed, by external experts, advisors or other Consortium members involved in the follow-up of third-party projects. These participants will take part in an advisory capacity, with voice but without vote.

The final decision will be made based on the evaluation results. During the Consensus Meeting, the Selection Committee will review and discuss the highest-ranked proposals under the relevant Cut-off Date and Funding Instrument. This process will result in a list of proposals selected for funding and, where relevant, a reserve list.

To support balanced participation across enlargement countries, proposals may be grouped or tagged according to the enlargement countries involved in each proposal. This country participation overview may be used by the Selection Committee when preparing the final list of selected proposals, taking into account the cumulative portfolio of projects selected across previous and current Cut-off Dates.

Keep in mind that although the highest-scoring proposals are usually chosen for funding, the Selection Committee can reject a candidate for valid reasons, such as misalignment with POLICY ENLARGE objectives, goals and scope, limited potential impact, commercial competition issues, serious ethical concerns, or possible conflicts of interest. In this case, the choice may pass to the next-ranked proposal.

The exact number of proposals approved will be decided based on the overall quality of the proposals, the available budget, the limits applicable to each Funding Instrument, and the need to ensure a balanced selection across enlargement countries.

4. Formal check & Agreement signature

Finalists will undergo a formal check to confirm their legal status and eligibility (e.g., registration document, financial documents, ownership structure, tax ID, etc.). Therefore, we will ask you to provide documents to confirm all the details.

To confirm your formal status, we may ask the applicants for: the entity's registration document, the legal representation document (optionally POA), tax ID number, financial statements, Bank Identification Form, Gender Equality Plan where applicable, and other documents in case of doubts raised during the checks. This list is not exhaustive.

For Funding Instrument #3, additional documents may be requested to confirm the status, affiliation and eligibility of the secondee(s), sending organisation(s) and host organisation(s).

Documents must be provided within the given deadline. If you don't deliver the requested documents on time, without a clear and reasonable justification, we will have to exclude you from further formal assessment.

After passing this check, we will invite you to sign the Sub-grant Agreement with the POLICY ENLARGE Consortium to officially participate in the programme.

5. After Sub-Grant Agreement signature

5.1. Payment conditions

The Grant will be paid as a lump sum and will not be linked to the reimbursement of actual costs incurred. Payments will be made upon successful completion and approval of the stages and deliverables defined in the Individual Follow-up Plan developed at the beginning of the Support Programme.

Payments are scheduled in tranches as follows:

- **Stage 1: Individual Follow-up Plan** - 25% of the Grant Amount by month 1, after approval of the Individual Follow-up Plan.
- **Stage 2: Final deliverable** - 75% of the Grant Amount by month 6, after approval of the final deliverable.

5.2. Progress evaluation

We pay upon the delivery of the agreed results - not upon delivery of certain receipts. Therefore, Consortium Partners, gathered in the Selection Committee, will evaluate your progress regularly.

Payment milestone	Explanation

Stage 1: Individual Follow-up Plan	Within the first month of the Support Programme, you will prepare an Individual Follow-up Plan, based on the presented proposal, outlining the final budget, KPIs and deliverables for performance assessment. The Individual Follow-up Plan will be evaluated by the Selection Committee, taking into account Deliverable quality (90%) and Deadline compliance (10%). Each criterion will be scored from 0 to 10, and the final score will be calculated based on the weights indicated. A score of 7 points or more is required to continue in the programme.
Stage 2: Final Deliverable	Before the final payment, the Selection Committee will review your progress. Performance will be evaluated based on: - Deliverables quality (30%); - KPIs (60%); - Deadline compliance (10%). Each criterion will be scored from 0 to 10, and the final score will be calculated based on the weights indicated. A score of 7 points or more is required to successfully complete the programme. For more details, please check the template of the Sub-grant Agreement.

The final score will be calculated based on the weight of each criterion.

A threshold of 7 points is required to continue in the programme. Third-party projects that perform as expected, will receive the corresponding part of the grant as a lump sum. Those not reaching the expected performance, will receive additional time for completion, will receive a reduced grant (if less than 7 points grant will be reduced following the scheme - 6-6,99 points - 25% reduction, 5-5,99 points - 50% reduction, less than 5 points - exclusion without payment) or will be invited to leave the program without receiving the corresponding payments, depending on individual situation.

7. Complaints

Please note that we will not review complaints related to the content of the expert evaluations.

Annex 1: Technical Annex – Project scope and eligible activities

The POLICY ENLARGE Open Call targets cross-border cooperation, collaborative uptake of results and people-to-people cooperation with and within enlargement countries. The Open Call includes three Funding Instruments.

Supported activities must be realistic, proportional to the size of the grant and implementable within a maximum period of 6 months.

Funding Instrument #1: Small Grants for Joint Regional Innovation Actions

Funding Instrument #1 supports joint actions supporting stakeholders from enlargement countries to develop collaborative R&I projects, access EU funding opportunities, strengthen R&I management and technology transfer capacities, and contribute to evidence-based policy reforms and digital and green transformation

Funding Instrument #1 supports joint regional innovation actions from enlargement countries to better internationalise and integrate into EU Research and Innovation actions and policy making. These grants act as catalyst to integrate participants into the European research and innovation ecosystem, thereby establishing a solid baseline of mutual cooperation. These joint innovation actions are intended to prepare for future, larger collaborative projects or activities to support the alignment with EU priorities. Projects must focus on small-scale, realistic, and innovative actions that promote regional integration.

For Funding Instrument #1: Small Grants for Joint Regional Innovation Actions: **consortia including at least two independent legal entities, each established in a different enlargement country are eligible.** The participating entities can be Companies, Research Organisations and Academia Research Groups, Non-profit entities, Digital Innovation Hubs /European Digital Innovation Hubs, and others relevant R&I actors.

Eligible activities include:

- **Joint R&I Small-Scale Innovation Actions:** small-scale actions supporting business-academia cooperation across enlargement countries. At least one entity from academia and one from the business sector should apply and cooperate.
- **Joint Innovation Actions for collaborative projects:** actions helping stakeholders from enlargement countries understand and access R&I funding programmes, such as – but not exclusively – Horizon Europe (e.g. RIA, IA projects or calls under Pillar III). Participants can organise different activities that contribute to building cooperation projects.
- **Joint R&I Capacity Building and Policy Support:** Technical assistance, training, workshops, and peer-learning initiatives between enlargement countries. Supported activities can focus on improving Research and Innovation (R&I) management, or technology transfer processes, or digital



skills, and/or facilitating R&I policy reforms (including evidence-based policymaking), such as the [Green Deal](#) and the [digital transformation](#).

Examples of expected outputs under Funding Instrument #1 may include:

- cooperation roadmap between partners from different enlargement countries;
- small-scale joint innovation action report;
- capacity-building materials;
- joint workshop report with conclusions and follow-up steps;
- technology transfer or innovation management roadmap;
- joint concept note for a future Horizon Europe or other EU-funded proposal;
- proposal preparation roadmap for a larger joint action.

Funding Instrument #2: Small Grants for Collaborative Uptake of Results

Funding Instrument #2 supports joint activities between enlargement countries' stakeholders to support Research and Innovation, regulatory or societal uptake of results.

For Funding Instrument #2: Small Grants for Collaborative Uptake of Results: **consortia including at least two independent legal entities, each established in a different enlargement country.** The participating entities can be Companies, Research Organisations and Academia Research Groups, Non-profit entities, Digital Innovation Hubs /European Digital Innovation Hubs, and others relevant R&I actors.

Eligible activities include:

- **Joint projects to integrate research findings into policies:** small-scale pilot projects demonstrating the practical application and societal benefits of R&I results in a real-world setting.
- **Joint projects to apply research results into society:** small projects involving end-users, citizens or specific communities in the development and validation of R&I solutions, ensuring relevance and increasing the likelihood of adoption.
- **Other joint uptake of results activities** aimed at supporting Research and Innovation, regulatory or societal uptake of results in enlargement countries.

Examples of expected outputs under Funding Instrument #2 may include:

- Joint uptake roadmap for research results;
- Joint policy brief or policy recommendation note;
- Cross-border stakeholder validation report;
- Joint societal uptake plan;
- Common regulatory uptake note;
- Cross-border end-user engagement report;



- Joint community validation report;
- Joint practical guidance note for applying research results;
- Joint action plan for wider adoption of research results;
- Joint dissemination and exploitation roadmap.
- Joint publication of the uptake of results in a scientific journal.

Funding Instrument #3: Small Grants for People-to-People Cooperation Projects

Funding Instrument #3 supports mobility programmes designed to support the implementation of people-to-people cooperation projects with and within enlargement countries.

For Funding Instrument #3: Small Grants for People-to-People Cooperation Projects: **consortia including participation of Researchers, Artists, or Entrepreneurs - affiliated with independent legal entities-**, established either in different Enlargement Countries or in an Enlargement Country and an EU Member State.

Eligible activities include:

- **Mobility programme for Researchers** from Higher Education Institutions and R&I organisations.
- **Mobility programme for Creative Professionals** from Creative Industries.
- **Mobility programme for Entrepreneurial Talent / Staff** from European Incubation Networks.
- **Other people-to-people cooperation projects** supporting partnerships between higher education institutions, creative professionals and industries, and European incubation networks for creativity-driven innovation.
- **Other people-to-people cooperation projects** supporting partnerships between the previous categories.

Funding Instrument #3 may support intra-enlargement secondments or cross-enlargement secondments. Secondments are the mechanisms through which mobility is implemented.

Intra-enlargement secondments involve two different enlargement countries. They require a reciprocal exchange, where one person from one enlargement country undertakes a secondment at a host organisation in another enlargement country, and an individual from the host organisation completes a secondment at the sending organisation. The duration of each secondment is 15 to 30 days per secondee. This type of collaboration is particularly encouraged, as it fosters shared learning, resource transfer and stronger relationships between enlargement countries.

Cross-enlargement secondments involve one enlargement country and one eligible host country. In this case, only a person from an enlargement country undertakes a secondment at a host entity in an EU Member State, its Overseas Countries and Territories, or a Horizon Europe Associated Country. The duration is limited to 15 days.



Research and innovation in both types of secondments, the proposed cooperation has to address issues related to research and innovation in enlargement countries in their programming and implementation.

Funding Instrument #3 may support people-to-people cooperation projects involving:

- Researchers affiliated with Research Organisations or Academia Research Groups established in enlargement countries;
- artists, designers, cultural heritage experts, media professionals and other creative individuals belonging to [Creative Industries](#) established in enlargement countries;
- entrepreneurs, start-up founders, innovators from SMEs or start-ups established in enlargement countries;
- staff from European incubation networks within enlargement countries.

All mobility projects must be cross-border, short-term and address Research and Innovation issues in enlargement countries.

The proposal should describe the expected activities during and after the secondment, including where relevant and proportionate :

- training;
- mentoring;
- capacity building;
- access to methods, networks, infrastructures or facilities;
- structured meetings with relevant stakeholders;
- peer-learning activities;
- knowledge transfer activities;
- transfer-back session or report after the mobility;
- follow-up cooperation roadmap.

Examples of expected outputs under Funding Instrument #3 may include:

- secondment report;
- transfer-back report;
- training or mentoring material jointly developed;
- cooperation roadmap;
- follow-up action plan or roadmap;
- skills development report;
- short methodology or practice note;
- joint concept note for future cooperation;
- stakeholder or network engagement report.

Quality expectations

Applicants should ensure that their proposed activities are clear, focused and proportionate to the available grant and timeframe.

A strong proposal should:



- clearly explain the cooperation needed;
- show why the proposed partners or host organisation are relevant;
- demonstrate a clear link with Research and Innovation needs in enlargement countries;
- describe realistic activities and outputs;
- include a credible work plan;
- explain how the results will be used after the project;
- contribute to the stronger integration of enlargement countries into EU Research and Innovation actions and policy making.
