Definition of a structured work plan tailored to the project. The Individual Mentoring Plan (IMP), a document that establishes the project's specific key performance indicators (KPIs) and deliverables.</p> <p>Stage 2: Scenario Definition (Up to 3 months), Identification of the relevant threat vectors and detailing the technical steps, tools, and methodologies required to safely replicate these threats in a controlled environment.</p> <p>Stage 3: Scenario Integration and Validation (Up to 2 months), the Mentors collaborate with participants to validate the scenarios, ensuring they accurately reflect emerging attack patterns and exploit techniques.</p> <p>CIRCAT OC1 beneficiaries have to design a Penetration Testing Scenario, following the template provided in Annex 1, in one of the CIRCAT prioritized verticals (Energy, Health, Public Administration, Digital infrastructure, ICT Service management (B2B) and the Financial market infrastructure).</p>
<p>Ground rules and formal requirements</p>	<p>When applying to the CIRCAT open call, please also note that the following conditions will be checked:</p> <ul style="list-style-type: none"> ● Submission deadline: Only proposals submitted through the online form LINK TO THE APPLICATION FORM before the deadline will be considered. ● Language requirement: Proposals must be written in English. If mandatory sections are in another language, the proposal will be rejected. Non-mandatory sections in another language will not be evaluated, but the proposal will remain valid. ● Data accuracy: The information you provide must be correct, complete, and allow proper evaluation. Extra material provided by you that was not requested in the form will not be considered. Although we may use other resources to verify that the provided data is true. ● Completeness: Ensure all required fields are filled. You can edit your submission until the deadline, but no changes are allowed after that.



- **European dimension:** Your proposal should align with EU goals and contribute to creating a positive impact within the EU.
- **Conflicts of interest:** We will check for any conflicts of interest between applicants and Consortium partners. Partners, their affiliated entities, and their employees cannot participate. Each case of conflict will be reviewed individually.
- **Financial stability:** Entities under liquidation, [in financial difficulty](#), or excluded from receiving EU funding are not eligible. We also exclude companies in bankruptcy.
- **Original work:** Execution of your project should not violate third-party IPR. It must be based on your intellectual property or you must be allowed to use third-party rights. IPR to the project can not be subject to any dispute.
- **AI content:** The use of AI tools to improve clarity and structure is permitted, provided the content remains accurate and fact-based. Applications may be rejected if found to be AI-generated and lacking a factual foundation. All submissions must be authentic reflections of the project, and the applicant team must evidence the technical and operational capacity required for implementation. Providing unverifiable or non-authentic information is grounds for immediate rejection.
- **Ownership control and governance:** We only accept entities that are registered in the Member States of the European Union or EEA. **CIRCAT does not accept entities that are directly or indirectly controlled by a person or entity established in a country that is not an eligible country (i.e. any country outside the EU Member States or EEA) or by an ineligible country entity.** This prohibition includes arrangements or coordination between shareholders from ineligible countries that would together exercise control, as well as any other financial or commercial links with ineligible countries or ineligible country entities conferring control.

2. Submission and evaluation process

Only proposals submitted through the [online form](#) before the Call Deadline (July 9, 2026, at 15:00 Brussels Time) will be considered. You will receive an email confirmation if the form is submitted correctly. If not, contact us immediately.

Our evaluation process is transparent, fair and equal to all participants. We will evaluate your project in a few phases described below. We will inform you about the results of the evaluation as soon as they become available.

2.1. Admissibility Check

After the closure of the Open Call, the system will review your proposal to ensure it meets the Call Terms and Conditions (section 1). This check will be based on the declarations in your proposal.

2.2. Pre-Scoring (if applicable)

If more than 70 proposals pass the initial check stage, a pre-scoring system may be implemented. Proposals will be automatically scored based on specific criteria:

As an applicant, choose the option that best fits your project for each criterion and confirm all your statements are true. We will check them during the next phases. If we identify false information, we may reject the proposal.

Your project can earn up to 75 points. The top 65 applications will move on to the next phase. Each question is automatically scored on a scale from 0 to 5 points based on the applicant's

selected answer from a drop-down menu. The final score is calculated automatically using the defined percentages.

- **Relevance (15% Weight | Maximum 11.25 points).** To assess the proposal's technological scope and its alignment with EU policies and supply chain security.
 - *Technological Scope.* How many of the targeted CIRCAT technologies (Networks, Applications, Virtualization, Cloud, Industrial Control Systems, IoT) does your scenario integrate?
 - *Policy Alignment.* How many EU regulatory frameworks (e.g., NIS2, DORA, EU Cyber Solidarity Act) does your scenario directly support for compliance?
 - *Digital Supply Chain Security.* What percentage of the digital assets in your proposed testing scenario are sourced from EU-based providers?
- **Impact (35% Weight | Maximum 26.25 points).** To evaluate the technical benefits of the scenario, specifically regarding vulnerability detection, asset coverage, and response times.
 - *Time to Detect (TTD) Reduction.* What is the estimated percentage reduction in the time elapsed between the occurrence of a cyber threat and its detection targeted by your scenario?
 - *Asset Coverage Rate.* What proportion of the organization's targeted infrastructure assets will the scenario be able to detect and assess?
 - *Vulnerability Target.* How many potential vulnerabilities do you estimate your scenario will expose and analyse?
- **Implementation (50% Weight | Maximum 37.5 points).** To measure the team's technical capacity, the maturity of the action plan, and resource allocation to execute the project.
 - *Action Plan Maturity.* How many distinct penetration testing phases are fully detailed in your current implementation plan?
 - *Team Expertise.* What is the combined cybersecurity experience of the core technical team dedicated to this project?
 - *Resource Allocation.* How many Full-Time Equivalent (FTE) personnel will actively work on defining the scenario?

Tie-Breaking Rules If two or more proposals receive the exact same total score at the cut-off threshold, the system will apply the following tie-breaking criteria automatically, in this specific order:

- The highest score obtained in the **Impact** section.
- The highest score obtained in the **Implementation** section.
- The highest score obtained in the **Relevance** section

2.3. Expert Evaluation

Eligible applications, or the 75 best proposals if pre-scoring has been applied, will be assessed, using predefined award criteria, by a panel consisting of **two external independent experts and one internal expert** selected from a **pool of cybersecurity experts**.

2.3.1. Relevance

This criterion assesses the extent to which the proposal aligns with the objectives and scope of the CIRCAT Open Call. Additionally, it assesses the level of contribution to European cybersecurity priorities. In particular, evaluators will consider:

The degree of alignment with CIRCAT objectives, including the development of penetration testing scenarios within the proposed verticals.

- The relevance of the targeted vertical sector, in relation to critical infrastructure and cybersecurity needs
- The appropriateness and clarity of the proposed technological scope (e.g., networks, cloud, ICS, IoT), and its suitability for the defined use case
- Contribution to long-term policy objectives, relevant policies and strategies, and frameworks (e.g., NIS2 Directive, EU cybersecurity strategy).
- The extent to which the proposal strengthens the security and resilience of the European digital supply chain.

2.3.2. Implementation

This criterion evaluates the quality, feasibility, and efficiency of the proposed implementation plan, as well as the capacity of the applicant to carry out the project. Evaluators will assess:

- The maturity and clarity of the proposed penetration testing scenario.
- Soundness and coherence of the implementation plan including work plan and timeline.

- The efficiency of allocation of resources including the level of effort.
- The availability and adequacy of the required infrastructure, tools, and testing environments (e.g., cyber range).
- The expertise, experience, and operational capacity of the applicant to implement the proposed plan.

2.3.3. Impact

This criterion assesses the expected outcomes and broader effects of the proposal, particularly in terms of societal and environmental benefits. Evaluators will consider:

- The contribution to strengthening cybersecurity resilience and improving the security posture of the targeted sectors or infrastructures.
- The potential to generate significant benefits for society, industry, or public services, including increased competitiveness and innovation capacity
- The degree of cross-border relevance and potential for collaboration or knowledge sharing across EU Member States
- The clarity of expected results in terms of vulnerability identification, risk mitigation, and operational improvements.

Each **criterion will be scored on a scale from 0 to 5 by the experts** in accordance with the award criteria. Evaluators will provide justifications for the scores awarded. The final score for each proposal will be calculated as the sum of the scores assigned by all evaluators for each criterion.

For each criterion, the minimum threshold is 3 out of 5 points. **The maximum total score will be 15 points, with a minimum total threshold of 10 points.**

Once there is an initial ranking, ties (if any) will be solved using the following criteria in order of priority:

- The highest score obtained in the **Impact** section.
- The highest score obtained in the **Implementation** section.
- The highest score obtained in the **Relevance** section
- Gender balance among the personnel responsible for carrying out the activities.

As a result of the Consensus Group, a 'Ranking List' will be produced. It will be procured in 6 ranking lists, one per CIRCAT prioritised vertical. All proposals above the threshold will move on to the next step.

2.4. Consensus Meeting

The Selection Committee, composed of consortium partners (CERTH, K3Y and FBA), will review and discuss the results of the expert evaluation. They will reach a consensus or majority of $\frac{2}{3}$ votes on the list of proposals to be selected, and the 'Selection Committee' will make sure, to ensure a balanced portfolio of supported activities in the different sectors, so that **up to 2 highest-ranked in the Energy, Health, Public Administration, Digital infrastructure and ICT Service management (B2B) verticals each and 8 in the Financial Entities. In addition, 1 proposal per vertical will be placed on a reserve list in case selected proposals drop out in later stages.**

Keep in mind that although the highest-scoring proposals are usually chosen for funding, the Selection Committee can reject a candidate for valid reasons, such as not fitting CIRCAT goals and scope, limited potential impact, commercial competition issues, serious ethical concerns, or possible conflicts of interest.

The exact number of proposals approved will be decided based on the overall quality of the proposals.

2.5. Interview (Optional)

An optional final step may be added to the selection process: an interview stage. The purpose of this stage is to support the final decision on which shortlisted proposals will participate in the support programme. Interviews will be conducted by the Selection Committee only if, during the Consensus Meeting, the Committee identifies outstanding questions or requires further clarification to determine the finalists.

2.6. Formal check & Agreement signature

Finalists will undergo a formal check to confirm their legal status (e.g., company registration, financial documents, ownership structure, tax ID, etc.) and ownership control and governance. Therefore, we will ask you to provide documents to confirm all the details:

- **To confirm the ownership, control, and governance of your entity**, you must submit the Ownership Control Declaration along with all required supporting documents.

- **To confirm your formal status, we may ask the applicants for:** the company's registration document, the legal representation (optionally POA), tax ID number, ownership structure³, financial statements, document/s confirming the staff headcount, Bank Identification form, and other documents in case of doubts raised during the checks (this list is not exhaustive)

Documents must be provided within the given deadline. If you don't deliver the requested documents on time, without a clear and reasonable justification, we will have to exclude you from further formal assessment.

After passing this check, we will invite you to sign the Sub-grant Agreement with the CIRCAT consortium to officially participate in the programme.

3. After the Sub-Grant Agreement signature

3.1. Payment conditions

The Grant will be paid in a lump sum. Payments depend on the successful and timely completion of each stage of the work planned and outlined in the Individual Mentoring Plan developed at the beginning of the Support programme. Payments are scheduled in tranches as follows:

Stage 1: Up to 10% of the Grant Amount by month 2

Stage 2: Up to 57,5% of the Grant Amount by month 4

Stage 3: Up to 32.5% of the Grant Amount by month 7

3.2. Progress evaluation

We pay upon the delivery of the agreed results - not upon the delivery of certain receipts. Therefore, Consortium Partners, gathered in the Selection Committee, will evaluate your progress regularly.

Please note that we will review only complaints related to:

- errors in the process caused by our staff,
- technical issues beyond the applicant's control,
- clear human or mechanical errors made by our staff,
- incorrectly marked statements, minor clerical errors, and obvious typographical mistakes.

Please note that we will not review complaints related to the content of the expert evaluations.

Complaints will be reviewed within seven (7) calendar days. If more time is needed, we will inform you via email. Anonymous complaints or those with incomplete information will not be considered.

6. Last but not least - final provisions

Any issues not covered by these Terms and Conditions are governed by Polish law, Digital Europe Programme rules, and EU grant regulations.

We make our best effort to keep all provided data confidential; however, for the avoidance of doubt, you are solely responsible for indicating your confidential or sensitive information as such. Please be aware that your application form will be shared with the external evaluators and CIRCAT Consortium partners.

You retain ownership of your intellectual property rights (IPR).

The signature of the Sub-grant Agreement is the initial condition to establish any obligations among applicants and any Consortium partners (with respect to the obligation of confidentiality of the application). The Sub-grant Agreement will include a set of obligations towards the European Commission (for example: promoting the project and giving visibility to the EU funding, maintaining confidentiality, and understanding potential controls by the EC/ECA, EPPO, and OLAF).

Please be aware that eligibility criteria will be checked throughout the process, including a final review and support programme.

In the event of any discrepancies between these Terms and their Annexes, the Terms shall prevail.

The CIRCAT Consortium reserves the right to cancel or modify the call at any time, informing applicants accordingly.
